CALL FOR ENTRIES

The 2019 East-Central Indiana regional arts exhibition is open to artists from Fayette, Rush, Henry, Wayne, Union, and Franklin counties and active members. Artists are invited to submit up to three pieces.

ELIGIBILITY: Open to any artist 18 years or older from Fayette and surrounding counties and current members. Only original work may be submitted in either amateur or advanced divisions. The amateur division includes work done under class supervision. The advanced division includes works from artists who have actively sold their work.

AWARDS: Cash awards will include Best of Show, 1st, 2nd & 3rd placings, other awards may include merit awards & purchase awards.

JUDGING: We are pleased to have Lance Crow from the Richmond Art Museum as our juror this year. Lance will determine class awards and merit awards.

FEES: \$15 fee per entry. (\$10 fee per entry with WVAA membership)

DEADLINE: Entries may be hand delivered to the WVAA Gallery on Friday, May 3, from 11-5pm and Saturday, May 4, from 10-2pm

OPENING RECEPTION & AWARDS

Opening Reception Friday, May 10, 2019 from 6-8

Exhibit will run until Friday, June 7, 2019.

Works may be picked up Friday, June 7, 2019 from 11-5pm and Saturday, June 8, 2019 from 10-2pm.

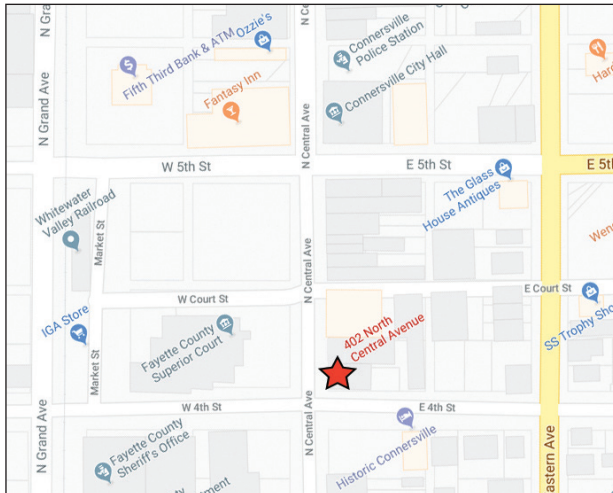
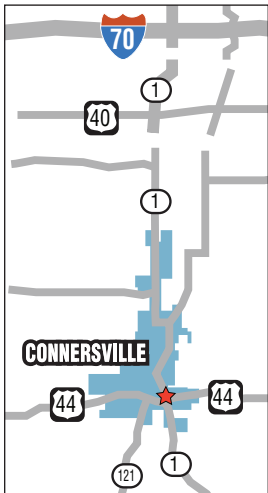
GENERAL REQUIREMENTS: All artwork must be original. Pieces must be framed, wired and ready to hang; no sawtooth hangers. Entry Forms must be filled out in full as well as two Entry labels per submission. For more hanging information go to: <http://wvartsa.com/images/archives/WVAA-artwork-requirements.pdf>
One of the Entry labels must be attached to the upper left corner on the back of each work. 2D work including frame or outside dimensions of wall hangings cannot exceed 40 inches by 40 inches. 3D pieces can be no larger than 24" x 24" by 5 feet tall. They must be able to stand on their own, and weigh no more than 40 lbs.

SALES: Entries available for purchase during the event must bear a sale price determined by the submitting artist or marked as NFS. Payment will be made directly to the artist from each purchaser. The WVAA will accept purchase fees on behalf of the artist. Sales funds will be given to the artist at the time works are picked up. Arrangements to mail funds can be made if all works are sold. The artist will be responsible for payments of Indiana State sales tax. The WVAA requires twenty percent commission of the purchase price from the artist or ten percent commission from WVAA members.

LIABILITY: Although reasonable care will be taken in handling and displaying artwork, the WVAA and its members will not be responsible for damage or loss. Due to the lack of storage space, artists must pick up their work at the designated time and location. Artists may make written arrangement for artwork pickup by another party. Work left after pick up dates will be removed to an offsite location.

Work left for longer than 7 days becomes the property of the WVAA.
